WHEREAS, Justright Healthcare Inc./Edmund S. Del Rosario is applying for the issuance of a Certificate of Exception for the Proposed Twelve (12)-Storey Mixed-Use Building with Roof Deck and Mezzanine located at Lot 2-C, Block 603, Palanza Street corner Guirayan Street, Barangay Doña Imelda, District IV, Quezon City;

WHEREAS, pursuant to Paragraph 2, Section 55, Article VIII of Ordinance No. SP-2502, S-2016, an Exception is required for the aforesaid Project upon authorization from the City Council;

WHEREAS, the Proposed Project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the Proposed Project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, shall pose no adverse effect on the zone or community;

WHEREAS, the Exception of the Proposed Project will not adversely affect the appropriate use of the adjoining property in the same district;

WHEREAS, the Exception of the Proposed Project will not alter the essential character and general purpose of the district where the Exception sought is located;

WHEREAS, the applicant has complied with all the necessary and mandatory requirements prescribed by law, ordinance or administrative issuances in support of the Proposed Project and undertakes to comply with the provisions of existing laws, ordinances, and rules and regulations pertaining to environmental protection, and vehicular traffic.
