WHEREAS, Republic Act No. 10066, otherwise known as "The National Cultural Heritage Act of 2009", emphasizes the protection and preservation of the Country's cultural heritage, including tangible and intangible cultural properties;

WHEREAS, the Implementing Rules and Regulations (IRR) of Republic Act No. 10066, recognizing the significance of all Cultural Properties, mandates the identification, documentation, and inventory of such properties to ensure their proper safeguarding and conservation;

WHEREAS, the Department of the Interior and Local Government (DILG) and the National Commission for Culture and the Arts (NCCA) jointly issued Joint Memorandum Circular No. 2018-01, known as the "Local Inventory of Cultural Property as required under Republic Act No. 10066", guiding local government units in identifying and inventorying their respective cultural properties;

WHEREAS, the NCCA issued Board Resolution No. 2017-330, entitled "Guidelines Governing the Philippine Registry of Cultural Property (PRECUP)", providing guidelines for the establishment and maintenance of the registry of significant cultural properties;

WHEREAS, the Quezon City Tourism Department created and updated the list of identified heritage, sites, landmarks, monuments and cultural resources and properties within the jurisdiction of Quezon City. 
