WHEREAS, Delta Stream Corporation applied before the Quezon City Council for a Special Use Permit for the operation of Petron Gasoline Refilling Station (As Built) located at Lots 62-D-1, C-1, B-1 and A-1-A, No. 368 Quirino Highway corner Tandang Sora Avenue, Barangay Sangandaan, District VI, Quezon City, which was granted through Resolution No. SP-8657, S-2021;

WHEREAS, the Petron Gasoline Refilling Station changed its operation and it was returned to its mother company the Petron Corporation to manage and operate the said station;

WHEREAS, pursuant to Section 52, Article VIII of Ordinance No. SP-2502, S-2016, a special use permit was previously issued by the City Council to Delta Stream Corporation;

WHEREAS, the said business will just change its operator from Delta Stream Corporation to Petron Corporation and the same nature of business will be operated as to that applied for Special Use Permit;
