WHEREAS, the City Mayor, Honorable Ma. Josefina G. Belmonte, issued the permanent appointment of Dave Anthony Alico Vergara as City Government Department Head II (Medical Center Chief I), with Salary Grade 26, at the Novaliches District Hospital of the Quezon City Government;

WHEREAS, Section 454(d) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations";

WHEREAS, Section 455(b)(1)(v) of the same Code, provides that the Local Chief Executive, acting as the appointing authority, shall appoint all officials and employees whose salaries and wages are wholly or mainly paid out of city funds and whose appointments are not otherwise provided for in this Code, as well as those he/she may be authorized by law to appoint;

WHEREAS, the said permanent appointment, which was signed by the City Mayor on July 3, 2023, shall take effect on the same date.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to confirm, as it does hereby confirm, the permanent appointment issued by the City Mayor, Honorable Ma. Josefina G. Belmonte, to Dave Anthony Alico Vergara as City Government Department Head II (Medical Center Chief I), with Salary Grade 26, at the Novaliches District Hospital of the Quezon City Government.
