SOTTO, AND THE HONORABLE MEMBERS OF THE $22^{\rm ND}$ QUEZON CITY COUNCIL TO THE FAMILY AND FRIENDS OF SECRETARY MARIA SUSANA "TOOTS" V. OPLE ON HER PASSING AND HONORING HER CONTRIBUTION TO THE WELFARE OF FILIPINO MIGRANT WORKERS

WHEREAS, Secretary Susan "Toots" V. Ople made a career championing the rights of Overseas Filipino Workers (OFWs);

WHEREAS, Secretary Toots, as she was fondly called, was chosen in 2022 to lead the newly-created Department of Migrant Workers (DMW) which is tasked to protect the rights and promote the welfare of migrant workers. The DMW performs all the powers and functions of seven (7)-merged agencies that cater OFWs;

WHEREAS, under the leadership of Secretary Toots, the DMW prioritized addressing welfare cases stemming from instances of abuse by foreign employers;

WHEREAS, among Secretary Toots' priority programs include looking into the effects of climate change on workers' welfare, the lack of decent jobs in the Philippines, the issue of illegal recruiters, and the feminization of labor migration;

WHEREAS, in 2004, Secretary Toots was appointed as Undersecretary of the Department of Labor and Employment (DOLE). She also founded and led the Blas Ople Policy Center and Training Institute (Ople Center), a non-profit organization that handles labor and migration;

WHEREAS, Secretary Toots' work at Ople Center became instrumental in facilitating the rescue of OFWs exploited in countries in the Middle East and Southeast Asia. The Ople Center campaigned against the use of Filipino migrant workers as drug mules in international drug rings;

WHEREAS, Secretary Toots pushed for the end of contractualization and sought the passage of an anti-age discrimination law so that Filipinos would not turn to work abroad after being rejected by local employers due to their age;

WHEREAS, President Ferdinand "Bongbong" Marcos, Jr., dubbed her as "a great champion for labor movement in the Philippines". The President praised Secretary Toots who dedicated her life and every waking moment to the welfare of laborers in general and migrant workers, in particular. She was tireless in her pursuit to supporting and protecting Filipino workers;

WHEREAS, the DMW on Tuesday announced the demise of Secretary Toots, who died at around 1:00 PM on August 22, 2023, after her long battle with breast cancer;

WHEREAS, Secretary Toots will be remembered for many things, but mostly for her compassion and commitment to making sure every Filipino migrant worker has the right to live and work decently.
