WHEREAS, Section 455(b)(1)(v) of the same Code, provides that the Local Chief Executive, acting as the appointing authority, shall appoint all officials and employees whose salaries and wages are wholly or mainly paid out of city funds and whose appointments are not otherwise provided for in this Code, as well as those he/she may be authorized by law to appoint;

WHEREAS, the said permanent appointment, which was signed by the City Mayor on May 5, 2023, shall take effect on the same date.
