WHEREAS, the United Nations Development Programme (UNDP) and the Quezon City Government executed the Memorandum of Understanding dated November 21, 2022 for the Accelerating Nationally Determined Contribution through Circular Economy in Cities (ACE) Project;

WHEREAS, in order to assist the Quezon City Government in pursuing a circular economy under the ACE Project, the UNDP purchased the following: one (1) Community-to-farm mobile organic waste recovery system, and twenty-five (25) Biogas digesters;

WHEREAS, the ACE Project is funded by the Government of Japan through a grant agreement with UNDP which has approved the transfer of ownership of the equipment through a Deed of Transfer and Acceptance;

WHEREAS, the UNDP, following its internal procedures, hereby voluntarily and gratuitously gives, transfers and conveys, with no charge, unto the Quezon City Government, its successors and assigns, free and clear from any and all liens and encumbrances whatsoever, all its rights, interest and title over the equipment;

WHEREAS, the Quezon City Government hereby accepts said donation and expresses its gratitude for the support and kindness of UNDP;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to sign and accept the Deed of Donation and Acceptance from the United Nations Development Programme (UNDP) and to sign and execute the related Deed of Transfer and Acceptance and UNDP'S Transfer of Title of Assets, for the donation of one (1) brand new six-wheeler truck for the community-to-farm mobile organic waste recovery system and twenty-five (25) biogas digesters.
