A RESOLUTION DISMISSING THE ADMINISTRATIVE COMPLAINT FOR GRAVE MISCONDUCT AND VIOLATION OF REPUBLIC ACT NO. 6713 FILED BY SITIO MENDEZ DAMAYAN ASSOCIATION, INC., REPRESENTED BY FRANCISCA AYTONA, ET AL., AGAINST RAMON ASPRER, LEONARDO MANAHAN, PERCIVAL CHAVEZ AND DICK TAN, BEFORE THE BLUE RIBBON COMMITTEE OF THE CITY COUNCIL, DOCKETED AS ADMINISTRATIVE CASE NO. 002-09, WHICH IS A SIMILAR COMPLAINT FILED IN THE OFFICE OF THE OMBUDSMAN

WHEREAS, on May 14, 2009, Sitio Mendez Association, Inc., represented by Francisca Aytona, et al., filed a Criminal and Administrative Complaint with the Office of the Ombudsman against Ramon T. Asprer, Leonardo Manahan, Percival Chavez and Dick Tan, docketed as OMB-C-C-09-0272-F and OMB-C-A-09-0287-F;

WHEREAS, on the same date, a case was filed before the Blue Ribbon Committee of the Quezon City Council, entitled "Sitio Mendez Damayan Association, Inc., Complainant, -versus- Ramon T. Asprer, Leonardo Manahan, Percival Chavez and Dick Tan, Respondents", and docketed as Administrative Case No. 002-09, using the same complaint paper that was filed with the Office of the Ombudsman;

WHEREAS, a Decision was rendered by the Office of the Ombudsman dismissing the aforementioned case and forwarded the said case to the Office of the Quezon City Blue Ribbon Committee for appropriate action.
