WHEREAS, the Local Chief Executive may, upon authority of the Sangguniang Panlungsod, negotiate and secure financial grants or donation in kind in support of basic services or facilities enumerated in Section 17 of Republic Act No. 7160;

WHEREAS, the Honorable City Mayor is mandated to enter into contracts in behalf of the Local Government with prior authorization by the Sanggunian concerned pursuant to Section 22(c) of the Local Government Code of 1991 (Republic Act No. 7160);

WHEREAS, under Section 17 of Republic Act No. 7160, the Local Government may exercise such powers and discharge such functions as may be necessary, appropriate or incidental to the delivery of basic services and facilities including tax information systems;

WHEREAS, the Department of Environment and Natural Resources (DENR) is collaborating and assisting with Quezon City Government, in compliance with the Supreme Court decision mandating the concerned government units to clean up, rehabilitate and restore the Manila Bay in order to maintain and restore its waters to SB level and make it fit for swimming and other forms of recreation;

WHEREAS, the DENR, in its desire to assist the Quezon City LGU, to improve, manage and rehabilitate its natural resources, will donate to the Local Government of Quezon City, the heavy equipment hereunder described as follows:
