A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO GJS TUBE ICE CORP. FOR THE OPERATION OF A TWO (2)-STOREY TUBE ICE MANUFACTURING PLANT (AS BUILT) LOCATED AT LOT 11, BLOCK 5, NO. 78 BUKIDNON STREET, BARANGAY RAMON MAGSAYSAY, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE OF 2016

WHEREAS, GJS Tube Ice Corp., a business entity duly registered under Philippine laws, is applying for the issuance of a Certificate of Exception for the operation of a Two (2)-Storey Tube Ice Manufacturing Plant (As Built) located at Lot 11, Block 5, No. 78 Bukidnon Street, Barangay Ramon Magsaysay, District I, Quezon City;

WHEREAS, the Sangguniang Barangay concerned, and the residents near the place of business therein interpose no objection to the operation of the said business establishment;

WHEREAS, the Proposed Construction will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the construction and operation of a Tube Ice Manufacturing Plant will provide employment and promote economic development in the City;

WHEREAS, pursuant to Paragraph 2, Section 55, Article VIII of Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016, a Certificate of Exception (COE) shall be required for the aforementioned Project subject to the authorization of the City Council through a Resolution;

WHEREAS, the Tube Ice Manufacturing Plant has complied with all the necessary requirements for the issuance of a Certificate of Exception as mandated by the Quezon City Comprehensive Zoning Ordinance of 2016.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to GJS Tube Ice Corp. for the operation of a Two (2)-Storey Tube Ice Manufacturing Plant (As Built) located at Lot 11, Block 5, No. 78 Bukidnon Street, Barangay Ramon Magsaysay, District I, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016.
