WHEREAS, Rishon LeZion, the third largest city with the highest quality of life in Israel, is a Sister-City of Quezon City after the virtual signing of the Agreement last April 2022, pursuant to Resolution No. SP-8488, S-2021;

WHEREAS, the Sister-City Agreement was further sealed when it was formally signed by Quezon City Mayor Ma. Josefina "Joy" G. Belmonte and Rishon LeZion Mayor Raz Kintslich, and when the Quezon City delegation did a benchmarking visit to the City of Rishon LeZion in May 2023;

WHEREAS, the City of Rizhon LeZion showed remarkable hospitality to our Quezon City delegation and it generously shared its best practices that might be useful to Quezon City;

WHEREAS, in the early morning of October 8, 2023, the Hamas group launched a surprise attack by land, air, and sea in Israel;

WHEREAS, the Hamas group launched this attack by firing rockets in several towns and cities, including the City of Rishon LeZion;

WHEREAS, the surprise attack has caused the death of about 1000 people and the number is expected to grow as the violence continues to persist;

WHEREAS, on October 9, 2023, the Office of the President released a statement condemning the attacks and expressing deepest sympathies to those who have lost loved ones in the fight between the Israeli military and the Hamas group;

WHEREAS, the Quezon City Government expresses heartfelt sympathy and is offering prayers to our Sister-City Rishon LeZion that has been affected by the October 8, 2023 attack in Israel.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to express, as it does hereby express heartfelt sympathy and offer prayers to our Sister-City Rishon LeZion that has been affected by the October 8, 2023 attack in Israel.
