WHEREAS, Summit Fuel Opc., a business entity duly registered under Philippine laws is applying for a Special Use Permit (SUP) to be used for the construction and operation of a proposed Two (2)-Storey Commercial Building (Portion of Uno Fuel Gasoline Station) located at Lot PCN-00-000969, Block 2, Commonwealth Avenue and Windsor Street, District V, Quezon City;
