A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE CENTER FOR INTERNATIONAL INDUSTRIES COMPETENCE CORP. TO BE ACCREDITED UNDER THE QUEZON CITY COMPETENCY ENHANCEMENT AND RETOOLING PROGRAM

WHEREAS, Quezon City affirms the constitutional recognition of the State's role in fostering a just and dynamic social order through policies that promote full employment and a rising standard of living, enshrined under Section 9, Article II of the Philippine Constitution;

WHEREAS, the City, through the Public Employment Service Office (PESO), is in the process of implementing City Ordinance No. SP-3108, S-2022, which declared it as a City's policy to promote employment opportunities within its jurisdiction and help in the employment goals of its constituents, by providing training for competency enhancement and making use of retooling as a means of employment intervention to facilitate recruitment and job placement;

WHEREAS, Section 9 of City Ordinance No. SP-3108, S-2022 provides that the PESO will provide a stipend to the qualified beneficiaries for a particular training program to help them finish their training. Furthermore, Section 10 of the same Ordinance stated that the training institutions evaluated and screened by PESO will enter into an agreement with the City Government for the training of beneficiaries;

WHEREAS, the Center for International Industries Competence Corp. is a non-stock, non-profit corporation, duly organized and existing under Philippine Laws, represented by its President, Arrish C. Altavano, and with principal office address at 4th Floor, No. 656 Del Monte Avenue, Barangay Talayan, District I, Quezon City;

WHEREAS, a Resolution to enter into a Memorandum of Agreement is encouraged wherein the City, through PESO, shall be responsible for the validation and screening of applicants for the program, while training institutions will conduct and provide training for qualified beneficiaries. Furthermore, the Memorandum of Agreement will provide for the necessary rules and regulations for training Institutions, as well as the PESO's corresponding responsibilities, and other agreements related thereto:

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor, as the Chief Executive of the City Government, shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Center for International Industries Competence Corp. to be accredited under the Quezon City Competency Enhancement and Retooling Program.
