(SHLDI), REPRESENTED BY ITS CORPORATE SECRETARY, MR. ROBERT A. LEUNG, FOR THE DONATION OF A ROAD LOT IDENTIFIED AS LOT NO. 85-A-1-B-2-K (ROAD) COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 004-2020007695 ISSUED BY THE REGISTRY OF DEEDS FOR QUEZON CITY, WITH AN AREA OF THREE HUNDRED EIGHTY-SIX (386) SQUARE METERS, LOCATED AT YSOBELLE-3 RESIDENCE, SARMIENTO STREET, BARANGAY STA. Belmonte, to execute and sign the Deed of Donation and Acceptance with Sweet Haven Land Developers, Inc. (SHLDI), represented by its Corporate Secretary, Mr. Robert A. Leung, for the donation of a road lot identified as Lot No. 85-A-1-B-2-K (Road) covered by Transfer Certificate of Title No. 004-2020007695 issued by the Registry of Deeds for Quezon City, with an area of three hundred eighty-six (386) square meters, located at Ysobelle-3 Residence, Sarmiento Street, Barangay Sta. Monica, District V, Quezon City.
