WHEREAS, Resolution No. SP-8906, S-2022 was adopted by the Quezon City Council last March 21, 2022 to become effective for 2 years or until 2024;

WHEREAS, Total Gamezone Xtreme Inc. decided to change the venue of its operation to Sta. Monica Shop and Ride, Block 5, Lot 95, 2nd Floor, 1004 Quirino Highway, Barangay Sta. Monica, Novaliches, District V, Quezon City due to the poor performance of its business in its previous location;

WHEREAS, Total Gamezone Xtreme Inc. is requesting the Quezon City Council to amend the existing Resolution by changing the address of its current operation to Sta. Monica Shop and Ride, Block 5, Lot 95, 2nd Floor, 1004 Quirino Highway, Barangay Sta. Monica, Novaliches, District V, Quezon City;

Monica Shop and Ride, Block 5, Lot 95, 2nd Floor, 1004 Quirino Highway, Barangay Sta. Monica, Novaliches, District V, Quezon City.

RESOLVED FURTHER, that this Resolution shall not renew nor extend the validity of Total Gamezone Xtreme Inc.'s previous Special Permit.
