WHEREAS, Total Gamezone Xtreme Inc. is requesting the Quezon City Council to amend the existing Resolution by changing the address of its current operation to Congressional Town Center, Congressional Avenue, Barangay Bahay Toro, District I, Quezon City;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the Quezon City Council to grant or renew the special permit of Traditional and Electronic Bingo, and to transfer its business location of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend, Resolution No. SP-8932, S-2022 entitled "A Resolution renewing the Special Permit of Total Gamezone Xtreme Inc. to operate Traditional and Electronic Bingo and Electronic Games at 716 Del Monte Avenue, Barangay Talayan, District I, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR)", by changing the business address therein to Congressional Town Center, Congressional Avenue, Barangay Bahay Toro, District I, Quezon City.

RESOLVED FURTHER, that this Resolution shall not renew nor extend the validity of Total Gamezone Xtreme Inc.'s previous Special Permit.
