RESOLUTION NO. SP- 9490 . S-2023

A RESOLUTION RENEWING THE SPECIAL PERMIT OF MUÑOZ BINGO CORPORATION TO OPERATE AN ELECTRONIC BINGO AT THE 3RD FLOOR, MUÑOZ PLAZA BUILDING, EDSA, BARANGAY VETERANS VILLAGE, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Muñoz Bingo Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, located at the 3rd Floor Muñoz Plaza Building, EDSA, Barangay Veterans Village, District I, Quezon City, is applying for the renewal of Special Permit to operate an Electronic Bingo (E-Bingo) Games;

WHEREAS, the applicant was previously granted a special permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8485, S-2021;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its special permit pursuant to an existing city ordinance;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a special Permit to business activities of the same nature.

WHEREAS, pursuant to Section 55, Article VIII, in relation to Section 73, Article IX of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, and considering the beneficial use of the Proposed Project, the same may be allowed in the project site upon authorization by the City Council for the issuance of a Certificate of Exception;

WHEREAS, the Proposed Project will not adversely affect public health, safety, and welfare of the inhabitants and is in keeping with the general pattern of development in the community;

WHEREAS, the applicant undertakes to comply with all the necessary and mandatory requirements prescribed by law, administrative issuances, and the existing Zoning Ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Muñoz Bingo Corporation to operate an Electronic Bingo establishment at the 3rd Floor, Muñoz Plaza Building, EDSA, Barangay Veterans Village, District I, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Bingo (E-Bingo) Games granted herein shall be subject to the following conditions:

- 1. The holding of E-Bingo Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
- 2. The operation of E-Bingo Games shall not include playing of games not related to or other than E-Bingo Games;
- 3. The operation is enjoined to prohibit from playing in the abovementioned games in their gaming site individuals below twenty-one (21) years of age or students of any school, college or university;
- 4. Muñoz Bingo Corporation shall remit to the City Treasurer's Office a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly during the lifetime of this Resolution, in accordance with Section 25 of Ordinance No. SP-2773, S-2018, as amended;

5. This Resolution is non-assignable, non-transferrable and site-address specific.

RESOLVED FINALLY, that this renewal of a Special Permit to operate E-Bingo Games shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed again by the City Council.
