WHEREAS, Manila Klean Fuel Corp., a duly registered business entity under Philippine laws, is applying for a Special Use Permit (SUP) for the construction and operation of a Clean Fuel Gasoline Refilling Station with One (1)-Storey/ Four (4) Units Commercial Space and Service Building located at Lot 791-A-5, Old Sauyo Road, Barangay Sauyo, District VI, Quezon City;

WHEREAS, pursuant to the provisions of the existing Quezon City Zoning Ordinance, a Gasoline Refilling Station is among the Uses which require the issuance of a Special Use Permit upon authorization from the Quezon City Council;
