WHEREAS, the purchase of the aforementioned parcel of land is for the purpose of establishing a permanent site for the barangay hall of Barangay Sacred Heart to enhance and accelerate the delivery of public service to its citizens;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into and sign a Deed of Sale for the purchase of a parcel of land registered under the name of Ma. Cristina Pipo Pre, covered by Transfer Certificate of Title No. 004-2011000978 and located at Scout Fuentebella Street, Barangay Sacred Heart, District IV, Quezon City, to be utilized as permanent site for the barangay hall of Barangay Sacred Heart.

RESOLVED FURTHER, that a copy of the aforesaid Deed of Sale shall form an integral part of this Resolution.
