A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE 10 AIR-CONDITIONING UNITS, 1 CABINET, AND 2 REFRIGERATORS TO BARANGAY HOLY SPIRIT, DISTRICT II, QUEZON CITY, AND TO TRANSFER THE OWNERSHIP THEREOF TO THE SAID RECIPIENT WITHOUT COST

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160 states that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance":

WHEREAS, the 10 air-conditioning units, 1 cabinet, and 2 units of refrigerator to be donated to Barangay Holy Spirit were purchased using the funds of the Quezon City Government;

WHEREAS, the said office equipment would significantly enhance the ability to provide efficient and effective services to the constituents of Barangay Holy Spirit, Quezon City;

WHEREAS, a Deed of Donation shall be given to Barangay Holy Spirit (Donee), transferring the ownership and authorizing said barangay to appropriate funds for the maintenance of these units from its own budget;

WHEREAS, the ownership of the same be transferred to the recipient, through a Deed of Donation, to be signed by the City Mayor, Honorable Ma. Josefina G. Belmonte as Donor and Punong Barangay Estrella C. Valmocina of Barangay Holy Spirit as Donee.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to donate 10 air-conditioning units, 1 cabinet, and 2 refrigerators to Barangay Holy Spirit, District II, Quezon City, and to transfer the ownership thereof to the said recipient without cost.

RESOLVED FURTHER, that a copy of the subject Deed of Donation shall form an integral part of this Resolution.
