IN THE AMOUNT OF PHP1,000,000.00, TO SUPPORT THE ANNUAL ROTARY INTERNATIONAL DISTRICT 3780 GOLDEN WHEEL AWARD, A VOCATIONAL EXCELLENCE AWARD PROJECT ANNUALLY SUPPORTED BY THE QUEZON CITY GOVERNMENT

WHEREAS, Section 36 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "A local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction";

WHEREAS, the Rotary International District 3780 Foundation, Inc. is a Non-Governmental Organization duly accredited by the Quezon City Government;

WHEREAS, the Rotary International District 3780, through the Rotary International District 3780 Foundation, Inc., will undertake the RI District 3780 Golden Wheel Award – a vocational excellence award project of the Rotary International District 3780 duly supported by the Quezon City Government;

WHEREAS, on March 21, 2024, the City Budget Department expressed that there is an available appropriation to grant the said financial assistance, chargeable under the Donation's Account, Social Services Program, Office of the City Mayor for Fiscal Year 2024 by virtue of Ordinance No. SP-3220, S-2023;
