RESOLUTION NO. SP- 9629 , S-2024

A RESOLUTION GRANTING THE ISSUANCE OF A SPECIAL PERMIT TO GAMEXPERIENCE ENTERTAINMENT CORP. FOR THE OPERATION OF ELECTRONIC SPECIALTY GAMES LOCATED AT THE GROUND FLOOR OF GREENHILLS TOWN CENTER, GRANADA STREET CORNER VALENCIA STREET, BARANGAY VALENCIA, DISTRICT IV, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Gamexperience Entertainment Corp., a domestic corporation duly organized and existing under and by virtue of Philippine laws, with business address at the Ground Floor of Greenhills Town Center, Granada Street corner Valencia Street, Barangay Valencia, District IV, Quezon City, Metro Manila, is applying for the issuance of a Special Permit to operate Electronic Specialty Games;

WHEREAS, the Electronic Specialty Games under Electronic Games are new gaming activities, regulated and sanctioned by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, to enable the applicant to conduct additional gaming activities in its business operations, there is a need to apply for another Special Permit for the operation of Special Gaming pursuant to an existing City ordinance;

WHEREAS, the operation of Electronic Specialty Games is regulated and licensed by PAGCOR;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the issuance of a Special Permit to Gamexperience Entertainment Corp. for the operation of Electronic Specialty Games located at the Ground Floor of Greenhills Town Center, Granada Street corner Valencia Street, Barangay Valencia, District IV, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate Specialty Games granted herein shall be subject to the following conditions:

- 1. The holding of Specialty Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- 2. The operation of Specialty Games shall not include playing of games not related to or other than Specialty Games;
- 3. The operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college or university;
- 4. Gamexperience Entertainment Corp., shall remit annually a license fee of 3% of the gross receipt of herein grantee, which shall be made payable to the City Treasurer's Office during the lifetime of this Resolution in accordance with Section 25 of Ordinance No. SP-2773, S-2018, as amended; and
- 5. This Resolution is non-assignable, non-transferrable and site-address specific.
