A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE NATIONAL HOUSING AUTHORITY (NHA), REPRESENTED BY ITS GENERAL MANAGER, JOEBEN A. TAI, AND THE MUNICIPALITY OF NORZAGARAY, BULACAN, REPRESENTED BY ITS MAYOR, HONORABLE MA. ELENA L. GERMAR, FOR THE PROVISION OF ASSISTANCE FOR PROGRAMS, PROJECTS, AND ACTIVITIES AMOUNTING TO PHP12,500,000.00, TO THE MUNICIPALITY OF NORZAGARAY, BULACAN, FOR THE BENEFIT OF RELOCATED INFORMAL SETTLER FAMILIES (ISFs) FROM QUEZON CITY

WHEREAS, it is the declared policy of the state to provide the people with adequate and decent housing facilities and to encourage various stakeholders to participate in the program of the government;

WHEREAS, Executive Order No. 90 s. 1986 issued by the Office of the President mandated the National Housing Authority (NHA) as the sole production agency to meet the housing needs of the low and marginal families in the urban and urbanizing areas;

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Republic Act No. 7279, otherwise known as the Urban Development and Housing Act of 1992, Local Government Units are mandated to take a principal role in the provision of housing services to their constituents;

*WHEREAS, the Quezon City Government (QCG) has relocated its Informal Settler Families (ISFs) to the resettlement site of NHA situated in the Municipality of Norzagaray, Bulacan;*

*WHEREAS, the Municipality of Norzagaray has agreed to receive ISF-relocatees from Quezon City to the said resettlement site situated within its territorial jurisdiction;*

*WHEREAS, the QCG shall provide the essential needs of the relocatees being well aware that to live a humane life at the relocation site, the resettled ISFs must have access to basic necessities such as education, health, permanent utility services, affordable transportation, peace and order, and livelihood programs;*

*WHEREAS, pending the availability and provision of post-relocation assistance and services mandated under the resettlement program of the national government, QCG agrees to provide support services in the areas of education, health, permanent utility services, affordable transportation, peace and order and livelihood programs to the Municipality of Norzagaray;*

*WHEREAS, Article 61(a) Inter-Local Government Unit Loans, Grants, Subsidies and Other Cooperative Undertaking of the Implementing Rules and Regulations of the Local Government Code of 1991 states that: "Province, cities and municipalities may, upon approval of a majority of all members of the sanggunian concerned and in amounts not exceeding their surplus funds, extend loans, grants or subsidies to other LGUs under such terms and conditions as may be agreed upon by the contracting parties";*

*WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor, shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.*

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into and sign a Memorandum of Agreement by and between the National Housing Authority (NHA), represented by its General Manager, Joeben A. Tai, and the Municipality of Norzagaray, Bulacan, represented by its Mayor, Honorable Ma. Elena L. Germar, for the provision of assistance for programs, projects, and activities amounting to Php12,500,000.00, to the Municipality of Norzagaray, Bulacan, for the benefit of relocated Informal Settler Families (ISFs) from Quezon City.
