A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACQUIRE THROUGH NEGOTIATED SALE AND TO EXECUTE A DEED OF ABSOLUTE SALE FOR THE PURCHASE OF A PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 004-2022001898 REGISTERED UNDER THE NAMES OF ALBERTINA D. FETALVERO MARRIED TO FELIFE FETALVERO AND JENNIFER ANNE D. MERCADO WITH AN AREA OF 600 SQUARE METERS, MORE OR LESS, LOCATED AT LOWER EMPIRE VIEW PARK SUBDIVISION, BARANGAY PAYATAS, DISTRICT II, QUEZON CITY, INTENDED FOR THE DEVELOPMENT OF A SOCIALIZED HOUSING PROJECT FOR THE BENEFIT OF THE QUEZON CITY'S INFORMAL SETTLER FAMILIES (ISFs)

WHEREAS, the Quezon City Government, through the Housing, Community Development and Resettlement Department (HCDRD), in its desire to provide greater opportunities to a significant number of Quezon City Informal Settlers/Residents to own an in-City, decent and affordable housing, has been relentless in its efforts to expand its socialized housing projects;

WHEREAS, Albertina D. Fetalvero married to Felipe Fetalvero and Jennifer Anne D. Mercado, the owners of the above-described parcel of land, in support of the LGU-QC's objective, have expressed willingness to sell the subject property to the Quezon City Government through a negotiated sale;

WHEREAS, the purpose of acquiring the above-described property is to develop the same into a socialized housing project for the benefit of the Informal Settler Families (ISFs) in Quezon City who will be screened and prequalified by a Beneficiary Selection Committee;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor, shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to acquire through negotiated sale and to execute a Deed of Absolute Sale for the purchase of a parcel of land covered by Transfer Certificate of Title No. 004-2022001898 registered under the names of Albertina D. Fetalvero married to Felife Fetalvero and Jennifer Anne D. Mercado with an area of 600 square meters, more or less, located at Lower Empire View Park Subdivision, Barangay Payatas, District II, Quezon City, intended for the development of a socialized housing project for the benefit of the Quezon City's Informal Settler Families (ISFs).
