A RESOLUTION RATIFYING THE CONTRACTS ENTERED INTO BY THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, ON THE PROVISION OF HEALTHCARE INSURANCE PROGRAM FOR ALL QUEZON CITY GOVERNMENT OFFICIALS, EMPLOYEES, CONSULTANTS, CONTRACT OF SERVICE AND JOB ORDER PERSONNEL, AND BARANGAY OFFICIALS

WHEREAS, pursuant to Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, on General Rule in Procurement or Disposal, it is the policy of the government that except as otherwise provided, acquisition of supplies and services by local government units shall be through competitive public bidding;

WHEREAS, Section 455(b)(1)(vi) of the Local Government Code of 1991 states that, "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance";

WHEREAS, Section 393(a) of the Local Government Code of 1991 provides that the "Barangay Officials, including Barangay Tanods and Members of the Lupong Tagapamayapa, shall receive honoraria, allowances and such other emoluments as may be authorized by law or barangay, municipal or city ordinance in accordance with the provisions of this Code";

WHEREAS, the Quezon City Government also donates to the Barangay;

WHEREAS, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Philippine Health Agenda 2016-2022 mandated the protection of Filipinos from health risks and financial risks to enable them to be healthy;

WHEREAS, the Quezon City Government, through the City Mayor, Honorable Ma. Josefina G. Belmonte, entered into contracts with the winning bidders and/or contractors for the healthcare and insurance program;

WHEREAS, Section 308 of the Local Government Code of 1991 provides that "Every local government unit shall maintain a General Fund which shall be used to account for such monies and resources as may be received by and disbursed from the local treasury. The General Fund shall consist of monies and resources of the local government which are available for the payment of expenditures, obligations or purposes not specifically declared by law as accruing and chargeable to, or payable from, any other fund";

WHEREAS, Ordinance Nos. SP-2977, S-2020, SP-3063, S-2021, and SP-3144, S-2022 covered the various expenditures for the operation of the Quezon City Government and appropriated the necessary funds for the purpose, for the years 2021, 2022, and 2023 respectively, which includes the following, specifically described as follows:
