A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE OF THE QUEZON CITY GOVERNMENT, TO ENTER INTO A DEED OF DONATION OF 1 UNIT OF FIRE TRUCK TO BE UTILIZED BY BARANGAY COMMONWEALTH, DISTRICT II, QUEZON CITY AND TO TRANSFER THE OWNERSHIP OF SAID VEHICLE WITHOUT COST

WHEREAS, the Quezon City Government agrees to donate 1 unit of an Isuzu Fire Truck with Engine No. 6HHI-279046 and Chassis No. FRR3304-7000132;

WHEREAS, the aforementioned Fire Truck will be used as a quick response unit to control fire especially in the innermost areas or locations of the community;

WHEREAS, to perfect the Deed of Donation, there is a need for the Donee's authorized signatory to accept the same through the signing of a Deed of Donation and Acceptance;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte of the Quezon City Government, to enter into a Deed of Donation of 1 Unit of Fire Truck to be utilized by Barangay Commonwealth, District II, Quezon City and to transfer the ownership of said vehicle without cost.

RESOLVED FURTHER, that a copy of the subject Deed of Donation shall form an integral part of this Resolution.
