*WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";*

*WHEREAS, there is a Deed of Donation and Acceptance with the purpose of donating 72 units of Utility Tents between the City Mayor Ma. Josefina G. Belmonte and 72 beneficiaries from District V, Quezon City;*

WHEREAS, the beneficiaries are from various group sectors and organizations in the community who are in need of Utility Tents for their public gatherings, meetings, recreation, or portable shelter against weather conditions;

WHEREAS, Utility Tents shall be distributed to qualified beneficiaries from Barangay Fairview, Barangay North Fairview, Barangay Greater Lagro, Barangay Kaligayahan, Barangay Pasong Putik, Barangay San Agustin, Barangay Novaliches Proper, Barangay Nagkaisang Nayon, Barangay Capri, Barangay San Bartolome, Barangay Bagbag, Barangay Gulod and Barangay Sta. Monica;

WHEREAS, the following are the specifications of the Tents to be donated and distributed:

**TENT 7 ft. x 13 ft.**

Custom made design tent, 7 ft. x 13 ft. frame made of diameter GI Pipe sched 20 with trustees for support post made of 1 ½ inches GI Pipe sched 20, roofing made of 220z tarpaulin seamed to fit frame and collapsible and easy to transport;

WHEREAS, the donation of 72 units of Utility Tents aims to improve the delivery of administrative services in District V, Quezon City;

WHEREAS, for the effective turnover of ownership of the 72 units of Utility Tents to the recipient organizations, the City, as Donor, shall assume all fees and costs of the Donation.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Deed of Donation and Acceptance with various beneficiaries from 14 Barangays in District V, Quezon City for the donation of 72 units of Utility Tents and authorizing the transfer of ownership to all recipients without costs.


