A RESOLUTION EXTENDING THE SINCEREST CONGRATULATIONS AND COMMENDATION OF THE QUEZON CITY GOVERNMENT TO SAMANTHA KYLE CATANTAN, FOR WINNING THE WOMEN'S FOIL EVENT IN THE 2024 ASIA-OCEANIA ZONAL OLYMPIC QUALIFIER IN FUJAIRAH, UNITED ARAB EMIRATES

WHEREAS, Samantha Kyle Catantan of Barangay Del Monte, District I, Quezon City, left an indelible mark on the history of Philippine fencing after she bagged the gold medal in the 2024 Asia-Oceania Zonal Olympic Qualifier on April 27, 2024 in Fujairah, United Arab Emirates;

WHEREAS, representing the Philippines, Samantha Kyle Catantan is the first Filipina fencer to compete in the Olympics;

WHEREAS, Samantha Kyle Catantan is a product of a grassroots community-based fencing program located in District I, Quezon City;

WHEREAS, on October 24, 2019, Samantha Kyle Catantan, who was only 17 years of age at the time, won the Gold Medal in the Asian Under 23-Fencing Competition held in Bangkok, Thailand;

WHEREAS, Samantha Kyle Catantan debuted her fencing career in the US-National Collegiate Athletic Association (US-NCAA) when she represented Pennsylvania State University and won a bronze medal in 2021;

WHEREAS, Samantha Kyle Catantan is currently pursuing a degree in accounting at Pennsylvania State University with a full scholarship;

WHEREAS, Samantha Kyle Catantan suffered an injury during the 32nd SEA Games and was diagnosed with an Anterior Cruciate Ligament (ACL) in her left knee. Despite the fact that her recovery was difficult, it did not stop her from winning the Women's Foil Event in the 2024 Asia-Oceania Zonal Olympic Qualifier;

WHEREAS, Samantha Kyle Catantan is the testament that no dream is unattainable as long as there is sacrifice, determination, perseverance, and discipline;
