RESOLUTION NO. SP- 9687 , S-2024

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION AND ACCEPTANCE FOR THE DONATION OF 3 UNITS OF LATERAL CABINETS IN DISTRICT I, QUEZON CITY, AND AUTHORIZING THE TRANSFER OF OWNERSHIP TO THE RECIPIENT WITHOUT COST

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, the following are the specifications of the Lateral Cabinets to be donated and distributed:

- 1. 4 Drawers with lock;
- 2. Gauge 20;
- 3. 46cm x 62cm x 134cm WXDXH; and
- 4. Color as per end user preferences;

WHEREAS, the said Lateral Cabinets shall be distributed for the barangay hall of Barangay Masambong, District I, Quezon City;

WHEREAS, the said Lateral Cabinets are to be used for storing and organizing important documents, such as contracts, invoices, minutes of the session of the Sangguniang Barangay and other records pertaining to the barangay;

WHEREAS, for the effective turnover of the ownership of the 3 units of Lateral Cabinets to the recipient, the City, as the Donor, shall assume all fees and costs of the donation.
