AUTHORIZING THECITY MAYOR, **HONORABLE** RESOLUTION MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION AND ACCEPTANCE FOR THE DONATION OF 19 UNITS OF MULTIMEDIA PROJECTORS TO DISTRICT I, QUEZON CITY, AND AUTHORIZING THE TRANSFER OF OWNERSHIP TO THE SAID RECIPIENTS WITHOUT COST

WHEREAS, Section 455(b)(1)(vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, Section 1, Article XIV of the 1987 Philippine Constitution states that "the State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all";

WHEREAS, 19 units of Multimedia Projectors shall be distributed to District I, Quezon City to be used in its various activities, and to create a more engaging and interactive learning;

WHEREAS, the following are the specifications of the said Multimedia Projectors to be donated and distributed:
