RESOLUTION NO. SP-9689, S-2024

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION AND ACCEPTANCE WITH VARIOUS BENEFICIARIES FROM THE 11 BARANGAYS IN DISTRICT I, QUEZON CITY, FOR THE DONATION OF 81 UNITS OF NEBULIZERS AND AUTHORIZING THE TRANSFER OF OWNERSHIP TO THE RECIPIENTS WITHOUT COST

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution declares that "the State shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, Nebulizers shall be distributed to qualified individuals in District I, Quezon City, specifically those who are suffering from asthma and other related respiratory illnesses;

WHEREAS, the individuals who are the qualified recipients of the said Nebulizers are residents of Barangays Alicia, Project 6, Pag-Ibig Sa Nayon, Sta. Cruz, Bahay Toro, Del Monte, Masambong, Vasra, Ramon Magsaysay, San Antonio and Balingasa;

WHEREAS, the donation of 81 units of Nebulizers aims to improve the delivery of administrative services in District I, Quezon City;

WHEREAS, for the effective turnover of the ownership of the said 81 units of Nebulizers to the recipients, the City, as the Donor, shall assume all fees and costs of the donation.
