A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO EXTEND FINANCIAL ASSISTANCE, ON BEHALF OF THE QUEZON CITY GOVERNMENT, IN THE AMOUNT OF PHP4,850,000.00 TO FUND THE PROJECTS AND ACTIVITIES OF THE QUEZON CITY PUBLIC SCHOOL TEACHERS ASSOCIATION (QCPSTA) FOR THE YEAR 2024, TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, AIDS, AND SUBSIDIES OF THE 2024 ANNUAL BUDGET OF QUEZON CITY OR FROM ANY AVAILABLE FUNDS

Proposed activities include medical check-up of teachers, Sanggunian para sa Edukasyon, and others;

WHEREAS, the QCPSTA, with its various welfare, training, and advocacy programs, is an important partner of the City Government in supporting teachers and employees and ensuring quality education in the City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to extend financial assistance, on behalf of the Quezon City Government, in the amount of Php4,850,000.00 to fund the projects and activities of the Quezon City Public School Teachers Association (QCPSTA) for the Year 2024, to be taken from the appropriation for grants, aids, and subsidies of the 2024 Annual Budget of Quezon City or from any available funds.
