WHEREAS, in 1936 at the Mayo Clinic, USA, Rehabilitation Medicine began as a specialty to treat impairments or disabilities arising from musculoskeletal and neurological diseases or problems;

WHEREAS, in the 1960s, a group of physiatrists and orthopedic surgeons interested in the field organized the Philippine Society of Physical Medicine and Rehabilitation. Said Society then had an active membership of less than twenty. In 1974, the Society's name was changed to Philippine Academy of Rehabilitation Medicine (PARM);
