A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO PURCHASE 171 UNITS OF MOTOR VEHICLES TO BE USED BY THE OFFICE OF THE CITY ADMINISTRATOR AND THE 142 BARANGAYS OF QUEZON CITY, FOR MONITORING AND COORDINATING FIELD OPERATIONS IN LINE WITH THE PROJECTS AND PROGRAMS OF THE QUEZON CITY GOVERNMENT TO BE TAKEN FROM THE AVAILABLE FUNDS OF THE CITY

WHEREAS, the Quezon City Local Government, as part of its continuing campaign in promoting a proactive stance in the preservation of our environment, will purchase Hybrid Electric Vehicles. Study shows that carbon dioxide emissions from vehicles are leading contributors to global warming. Hybrid vehicles release less of these harmful greenhouse gases by supplementing the power they derive from fuel sources with electrical power. This helps slow the progression of global warming and preserve the long-term future of our planet;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to purchase 171 Units of motor vehicles to be used by the Office of the City Administrator and the 142 Barangays of Quezon City, for monitoring and coordinating field operations in line with the projects and programs of the Quezon City Government to be taken from the available funds of the City.
