A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO WYN FUNERAL SERVICES/RODEL N. LOBO FOR THE PROPOSED 2-STOREY FUNERAL HOME LOCATED AT LOT 9, BLOCK 532, G. ARANETA AVENUE, BARANGAY TATALON, DISTRICT IV, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016
