WHEREAS, Suarez Metaplas Industries, Inc. is applying for a Certificate of Exception as to Land Use and Parking Requirements for the construction and operation of its Project, a 3-Storey Storage Room, 1-Storey Warehouse with Mezzanine and 3-Storey Warehouse with Roof Deck (All As Built), located at Lot 10, Block IN-1, (No. 130) 20th Avenue, Barangay Tagumpay, District III, Quezon City;
