A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO SIGN THE DEED OF DONATION OF 1 CITY-OWNED MOTOR VEHICLE TO BARANGAY EAST KAMIAS, DISTRICT III, QUEZON CITY AND TO TRANSFER ITS OWNERSHIP TO THE RECIPIENT BARANGAY WITHOUT COST, SUBJECT TO EXISTING LAWS AND REGULATIONS
