A RESOLUTION DECLARING A STATE OF CALAMITY IN QUEZON CITY DUE TO TYPHOON CARINA AND THE ENHANCED SOUTHWEST MONSOON (HABAGAT), AUTHORIZING THE USE OF AVAILABLE CITY AND BARANGAY CALAMITY FUNDS, AND FOR OTHER PURPOSES

WHEREAS, Section 16 of Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010," empowers the Local Government Units (LGUs) to implement measures to reduce the risk of disasters and improve their response and recovery capabilities;

WHEREAS, the Revised Guidelines for the Declaration of a State of Calamity under National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum Order No. 60, s.2019 provides the criteria and authority for the declaration of a state of calamity;

WHEREAS, the entire Metro Manila, including Quezon City, has been severely affected by heavy rain and flooding brought by the Southwest Monsoon or Habagat, enhanced by Typhoon Carina (Gaemi), causing significant displacement and damage to infrastructure, homes and livelihoods;

WHEREAS, the declaration of a state of calamity will facilitate the mobilization of resources, expedite the delivery of relief services, and enable the Quezon City Government and concerned agencies to implement necessary interventions to assist affected communities and restore normalcy;

WHEREAS, the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC) has conducted a rapid damage assessment and needs analysis, indicating widespread destruction and the urgent need for immediate relief and rehabilitation efforts.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SPECIAL SESSION ASSEMBLED, to declare, as it does hereby declare, a State of Calamity in Quezon City due to Typhoon Carina and the enhanced Southwest Monsoon (Habagat), authorizing the use of available city and barangay calamity funds, and for other purposes.

RESOLVED FURTHER, that the City and its Barangays are hereby authorized to use the available calamity funds or Quick Response Funds (QRF) duly allocated for the purpose.

RESOLVED FINALLY, that a copy of this Resolution be furnished to the following National Agencies for their information and guidance, and to request for their assistance and appropriate actions:
