AN ORDINANCE AMENDING THE POSITION TITLES OF LDRRM OFFICER AND BUDGET OFFICER II UNDER SECTION 4.4 OF ORDINANCE NO. SP-3170, S-2023, OTHERWISE KNOWN AS "AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. SP-2424, S-2015, REORGANIZING ITS ORGANIZATIONAL STRUCTURE, CREATING AN ADDITIONAL FIFTY-ONE (51) PLANTILLA POSITIONS AND ABSORBING FOUR (4) PLANTILLA POSITIONS FROM DISASTER CONTROL DIVISION (DCD), DEPARTMENT OF PUBLIC ORDER AND SAFETY (DPOS) TO THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (QCDRRMO), AND APPROPRIATING FUNDS THEREFOR"

WHEREAS, for purposes of publication, promotion and filling-up of vacant positions, there is a need to amend Section 4.4 of Ordinance No. SP-3170, S-2023, pursuant to Local Budget Circular No. 137, otherwise known as "Index of Occupational Services, Positions, Titles and Salary Grades in Local Government (IOS-LGU), CY 2021 Edition".

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. To amend Section 4.4 of Ordinance No. SP-3170, S-2023 and be read as:

"4.4 **Creation of Position** – Fifty-one (51) new positions are hereby created as appropriate to the functional requirements and workload of the DRRMP, thus:

<b>Office of the Head</b>		
1	City Government Assistant Department Head III	25
<b>Finance and Property Section</b>

The other positions, title, and corresponding salary grade/s created under Section 4.4 of Ordinance No. SP-3170, S-2023 shall remain valid and subsisting.

SECTION 2. REPEALING CLAUSE. – All ordinances, executive orders or parts thereof which are inconsistent with the provisions of this Ordinance are hereby amended, modified, and/or repealed accordingly.

SECTION 3. SEPARABILITY CLAUSE. – If, for any reason, parts or provisions of this Ordinance are held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.


