ORDINANCE NO. SP-3209, S-2023

AN ORDINANCE GRANTING ADDITIONAL INCENTIVE TO ALL QUEZON CITY GOVERNMENT EMPLOYEES INCLUDING CONTRACT-OF-SERVICE, JOB ORDERS AND CONSULTANTS, IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00) TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE QUEZON CITY GOVERNMENT

WHEREAS, an Unqualified Opinion is the highest audit opinion that COA awards to a government agency including a local government unit;

WHEREAS, with the sound financial management of the City, it is high time that the salaries of employees must be taken into consideration;

WHEREAS, as the Government bounces back from the impact of the pandemic in 2020 until 2022, and as Filipinos endure the increasing prices of the prime and basic commodities, the grant of additional incentive to all Quezon City Government employees is imperative and necessary in consideration of the various achievements of the City Government for 2022;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. An additional incentive is hereby granted to all Quezon City Government employees including all Contract-of-Service, Job Orders and Consultants in the Quezon City Government in the amount of Ten Thousand Pesos (Php10,000.00).

SECTION 2. The amount necessary to cover this additional incentive is hereby appropriated to be taken from any available funds of the City.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
