Belmonte, to extend financial assistance to the Quezon City Ladies Foundation Inc., in the amount of Php2,000,000.00 to fund the projects and activities to be taken from the Appropriations of Grants, Aids, and Subsidies under the Office of the City Mayor or from any available funds.
