WHEREAS, the Kapisanan ng mga Gurong Retirado (KAGURO) and the Association of Retired Teachers (ART) unified to form URTASI. The latter is composed of retired elementary and secondary teachers, principals and supervisors, and they were duly accredited by the 22nd City Council, under Ordinance No. SP-3137, S-2022, as one of the Civil Society Organizations in Quezon City;

WHEREAS, the URTASI is requesting for the grant of Php1,000,000.00 for the purpose of their Mutual Aid Program, Health and Wellness Program, Social and Cultural Activities, and Maintenance and Operational expenses;
