WHEREAS, the Quezon City Government, through the City Mayor, Honorable Ma. Josefina G. Belmonte, signed a Funds Disbursement Service Agreement (FDSA) with G-Xchange, Inc. (GXI) on August 29, 2022, for the disbursement of financial assistance to qualified beneficiaries;

WHEREAS, Quezon City Youth Development Office (QCYDO) implements the Quezon City Scholarship Program that includes, among others, academic, athletic and arts, and leadership scholarships;

WHEREAS, the disbursement of scholarship assistance to qualified beneficiaries under the QCYDO will be done through cash cards under the services of GXI, thereby expanding the initial FDSA;

WHEREAS, as an additional service, GXI will provide free GCash cards for up to 20,000 scholars during the school year when the Agreement subject of this Resolution is approved;

WHEREAS, the disbursement of scholarship assistance through GXI will ensure the efficient provision of scholarship benefits to support the education of Quezon City students.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Mayor, Honorable Ma. Josefina G. Belmonte, on behalf of the Quezon City Youth Development Office (QCYDO), to enter into and sign the Amended Implementing Agreement (Funds Disbursement Service) with G-Xchange, Inc. (GXI) for the disbursement of grants under the Quezon City Scholarship Program.


