TENTS TO THE DIFFERENT BARANGAYS OF DISTRICT VI, WITHOUT COST, AND TO TURN OVER DOCUMENTS PERTINENT TO THEIR OWNERSHIP, SUBJECT TO EXISTING RULES AND REGULATIONS

WHEREAS, the City owns units of tents particularly described as follows:

1. 22 units of 8ft. x 10ft.
 - Supply of labor and materials
 - Using GI pipes, $\frac{3}{4}$, 1 $\frac{1}{4}$ s.20 painted finish
 - BI round bar 8mm, BI washer 3", GI Bolt and nut
 - Nylon rope 3mm and 17 oz tarp with full color
 - Digital print seam to fit frame finish, with Quezon City logo

2. 22 units of 8ft. x 8ft.
 - Supply of labor and materials
 - GI pipes, $\frac{3}{4}$, 1 $\frac{1}{4}$ s.20 painted finish
 - BI round bar 8mm, BI washer 3", GI Bolt and nut
 - Nylon rope 3mm and 17 oz tarp with full color
 - Digital print seam to fit frame finish, with Quezon City logo

WHEREAS, said tents were already issued to the recipients under relevant Property Acknowledgement Receipt (PAR);

WHEREAS, this is in keeping with the thrust of the City to donate/transfer, without cost, equipment already assigned/issued or are not directly utilized by the City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into and sign the Deed of Donation of 22 units of 8ft. x 10ft. and 22 units of 8ft. x 8ft. tents to the different barangays of District VI, without cost, and to turn over documents pertinent to their ownership, subject to existing rules and regulations.
