A RESOLUTION RENEWING THE SPECIAL PERMIT OF AB LEISURE EXPONENT, INC. FOR THE OPERATION OF A TRADITIONAL AND ELECTRONIC BINGO GAMES ESTABLISHMENT AT FARMERS PLAZA, ARANETA CENTER, CUBAO, BARANGAY SOCORRO, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, AB Leisure Exponent, Inc., a domestic corporation duly organized and existing under and by virtue of Philippine laws, is applying for the renewal of its Special Permit for the operation of a Traditional and Electronic Bingo Games Establishment located at Farmers Plaza, Araneta Center, Cubao, Barangay Socorro, District III, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same Traditional and Electronic Bingo Establishment through Resolution No. SP-8762, S-2021;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City Ordinance;

WHEREAS, the operation of a Traditional and Electronic Bingo Games Establishment is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of AB Leisure Exponent, Inc. for the operation of a Traditional and Electronic Bingo Games Establishment at Farmers Plaza, Araneta Center, Cubao, Barangay Socorro, District III, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate a Traditional and Electronic Bingo Games Establishment granted herein shall be subject to the following conditions, to wit:

- 1. the holding of Traditional and Electronic Bingo Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
- 2. the operation of a Traditional and Electronic Bingo Games Establishment shall not include playing of games not related to or other than Traditional and Electronic Bingo Games;
- 3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college or university;
- 4. AB Leisure Exponent, Inc. shall remit a license fee of 3% of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25, Article III of Ordinance No. SP-2773, S-2018, as amended; and
- 5. this Resolution is non-assignable, non-transferrable and site-address specific.
