WHEREAS, Section 13, Article II of the 1987 Constitution provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth patriotism and nationalism and encourage their involvement in public and civic affairs;

WHEREAS, through Republic Act No. 10742, otherwise known as the "Sangguniang Kabataan Reform Act of 2015," the State aimed to establish adequate, effective, responsive and enabling mechanisms and support systems that will ensure the meaningful participation of the youth in local governance and nation-building;

WHEREAS, the Philippine Sangguniang Kabataan Awards is the premier national search and a seal of excellence for Sangguniang Kabataan (SK) committed to building a better Philippines through local high-impact innovations. The PSKA aims to highlight the most outstanding youth-led initiatives among SKs by implementing a comprehensive assessment system that supports local youth development. The PSKA, first launched in 2019, is a collaborative initiative organized by the Positive Youth Development Network and the National Youth Commission, in partnership with the Unilab Foundation and Ideas Positive;

WHEREAS, the 5<sup>th</sup> PSKA, held on August 12, 2024, honored the Sangguniang Kabataan recently elected in the previous year for the early contributions in advancing the promise of the Philippine Youth Development Plan, Ambisyon Natin 2040, and the UN Sustainable Development Goals;

WHEREAS, several of Quezon City's Sangguniang Kabataan won during the 5<sup>th</sup> PSKA. These include the Sangguniang Kabataan of Barangay Sauyo, District VI, Quezon City, which won in the Outstanding Sangguniang Kabataan Project Category for its project entitled "Project C.A.R.E.";

WHEREAS, the acronym "C.A.R.E." in the said Project stands for "Comprehensive Approach for Rescue and Emergencies." Project C.A.R.E. focuses on emergency preparedness for students and families in informal settlements in Areas 5A and 5B of Barangay Sauyo, Quezon City. The project trained 304 youth in emergency response, established the Barangay Sauyo Youth Emergency Auxiliary (BSYEA) and distributed 500 first aid kits and fire safety equipment. As a result, more students are now certified in first aid, and community awareness has improved with over 70% scoring well in post-training emergency preparedness tests. Regular safety initiatives have also increased active community engagement. The project enhanced immediate resilience and fostered a lasting culture of preparedness and community empowerment;

WHEREAS, the achievement of the Sangguniang Kabataan of Barangay Sauyo, District 6, Quezon City in implementing Project C.A.R.E. has successfully fostered positive social and behavioral changes within the community. It integrated emergency preparedness into the organizations of Sauyo High School and ensured that future students continue to receive essential training. This initiative caused volunteerism to surge, enhanced the ability of the community to respond to emergencies and instilled a culture of preparedness and resilience that will benefit Barangay Sauyo for years to come. The recognition of the accomplishment of the Sangguniang Kabataan of Barangay Sauyo will further serve to promote the positive outcomes from the project.

NOW, THEREFORE,


