A RESOLUTION REQUESTING THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE PROVISION OF 1 MOBILE CLINIC TO BE USED IN THE DELIVERY OF SOCIAL WELFARE, HEALTHCARE, AND DISASTER RESPONSE SERVICES CLOSER TO THE RESIDENTS OF QUEZON CITY

WHEREAS, the Department of Social Welfare and Development (DSWD), under Executive Order (EO) No. 15, Series of 1998, as amended by EO No. 221, Series of 2003, as the primary social welfare agency and an enabler and partner of Local Government Units (LGUs), is mandated to provide Technical Assistance and Resource Augmentation to LGUs, Non-Governmental Organizations, other National Government Agencies, People's Organizations, and other Civil Society Organizations in effectively implementing programs, projects, and services designed to uplift and alleviate poverty and empower disadvantaged children, youth, women, older persons, persons with disabilities, families or persons in crisis or at-risk, and communities needing assistance;

WHEREAS, Section 16 of Republic Act (RA) No. 7160, otherwise known as the "Local Government Code of 1991," mandates every Local Government Unit to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, which includes providing efficient social welfare services within their territorial jurisdictions;

WHEREAS, pursuant to Section 17 of the same Code, the LGUs shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. It shall also discharge the functions and responsibilities of national agencies and offices pursuant to the said Code;

WHEREAS, Republic Act No. 10121, or the "Philippine Disaster Risk Reduction and Management Act of 2010," directed the government agencies and LGUs to give top priority and take adequate appropriate measures in disaster risk reduction and management. Section 15 thereof recognizes the primary responsibility of LGUs as first disaster responders who take the lead in preparing for, responding to, and recovering from the effects of any disaster;

WHEREAS, a City Council Resolution requesting the DSWD to provide a mobile clinic is one of the requirements for its turn-over to the Quezon City Government;

WHEREAS, pursuant to Section 455(b)(1)(vi) of the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request, the Department of Social Welfare and Development (DSWD) for the provision of 1 Mobile Clinic to be used in the delivery of social welfare, healthcare, and disaster response services closer to the residents of Quezon City.

RESOLVED FURTHER, that the City Council hereby authorizes, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with Department of Social Welfare and Development for the provision of 1 Mobile Clinic to be used in the delivery of social welfare, healthcare, and disaster response services that is closer to the residents of Quezon City

RESOLVED FINALLY, that a copy of the subject Memorandum of Agreement shall form an integral part of this Resolution.
