AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF BLESSED MORNING HOMEOWNERS ASSOCIATION, INC. WITH 35 SALEABLE LOTS, COMMUNITY MORTGAGE PROGRAM (CMP), LOCATED AT LOTS 107 AND 110, FLS-2696-D, BLOCK 1, NO. 149 IDANG STREET, BARANGAY STA. MONICA, NOVALICHES, DISTRICT V, QUEZON CITY, METRO MANILA, REGISTERED IN THE NAME OF SOLOMON S. EVANGELISTA, MARRIED TO LOURDES G. EVANGELISTA, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-268685 OF THE REGISTRY OF DEEDS FOR QUEZON CITY, CONSISTING OF AN AGGREGATE AREA OF 1,817.00 SQUARE METERS, AS REPRESENTED BY ITS HOA PRESIDENT FRANCIS ROXAN ANGELICA N. LAUZA, SUBJECT TO COMPLIANCE WITH THE MINIMUM REQUIREMENTS OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BILANG 220
