RESOLUTION NO. SP-9805, S-2024

A RESOLUTION EXPRESSING THE QUEZON CITY GOVERNMENT'S FULLEST SUPPORT FOR THE SUCCESSFUL IMPLEMENTATION OF THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT'S PAMBANSANG PABAHAY PARA SA PILIPINO (4PH) PROGRAM

WHEREAS, President Ferdinand R. Marcos, Jr. issued Executive Order No. 34, s. 2023 which declared the "Pambansang Pabahay Para sa Pilipino" (4PH) Program as a "flagship program of the government," and directed Local Government Units (LGUs) to "provide full support to and cooperation with" the Department of Human Settlements and Urban Development (DHSUD) to ensure its successful implementation;

WHEREAS, the DHSUD launched the 4PH Program with the aim of servicing the Country's housing needs, targeting Informal Settler Families in the Country, especially those living under poor conditions, in blighted areas, within easements, beside railroads or waterways or in dangerous areas posing serious health risks and exposure to human-made or natural hazards;

WHEREAS, the DHSUD, in partnership with LGUs, envision's developing and transforming informal settlements and blighted areas into better residential developments with reasonable open spaces for outdoor activities promoting, to the extent possible, onsite or near-site in-City housing or resettlement through the development of low, medium to high-rise housing projects;

WHEREAS, the successful implementation of the 4PH Program will enable the poorest of the poor and most vulnerable QCitizens to retain easy accessibility to and from their places of employment or livelihood, and to avoid the potential loss of employment or source of income;

WHEREAS, the Quezon City Government itself has been proactive in improving the security of tenure of QCitizens, especially those who are underprivileged and homeless, towards empowerment, self-reliance and productivity;

WHEREAS, to support this aim, the Quezon City Government has institutionalized important housing and resettlement policies such as City Ordinance No. SP-2129, S-2012 (upgrading and reorganizing the Urban Poor Affairs Office as the Housing, Community Development and Resettlement Department), City Ordinance No. SP-2187, S-2012 (maintaining a Management Information System) and City Ordinance No. SP-2771, S-2018 (the Quezon City Socialized Housing Code of 2018);

WHEREAS, the Quezon City Government fully supports the efforts of the DHSUD in fulfilling its mandates under Republic Act No. 11201 and aligns itself with the State policy of "pursu[ing] the realization of a modern, humane, economically-viable, and environmentally-sustainable society where the urbanization process is manifest in towns and cities being centers of productive economic activity and is led by market forces; where urban areas have affordable housing, sustainable physical and social infrastructure and services facilitated under a democratic and decentralized system of governance; and where urban areas provide the opportunities for an improved quality of life and the eradication of poverty";

WHEREAS, the Quezon City Government recognizes the initiatives and innovations of the DHSUD, under the admirable leadership of Honorable Secretary Jose "Jerry" Rizalino L. Acuzar, towards ensuring that underprivileged and homeless QCitizens have access to adequate, safe, secure, habitable, sustainable, resilient and affordable homes.
