A RESOLUTION RENEWING THE SPECIAL PERMIT OF DANGAY OFF TRACK BETTING TO OPERATE AND MAINTAIN AN OFF-TRACK BETTING STATION AT NO. 14-B DANGAY STREET, BARANGAY VETERANS VILLAGE, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE GAMES AND AMUSEMENT BOARD

WHEREAS, Dangay Off Track Betting, a domestic company duly registered and existing under and by virtue of Philippine laws, owned by Mr. Rolando G. Catiis, with business address at No. 14-B Dangay Street, Barangay Veterans Village, District I, Quezon City, is applying for the operation of an Off-track Betting Station;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of an Off-Track Betting Station under Manila Cockers Club Inc. through Resolution No. SP-8076, S-2020;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City Ordinance;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Dangay Off Track Betting to operate and maintain an Off-Track Betting Station at No. 14-B Dangay Street, Barangay Veterans Village, District I, Quezon City, subject to the rules and regulations promulgated by the Games and Amusement Board.

RESOLVED FURTHER, that the authority to operate an Off-Track Betting Station granted herein shall be subject to the following conditions:

1. the subject establishment shall not be a nuisance to public safety and order;
2. Dangay Off Track Betting complies with all clearances, documentary requirements and other applicable local and national laws;
3. their operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college or university;
4. Dangay Off Track Betting shall remit a license fee of 3% of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25, Article III of Ordinance No. SP-2773, S-2018, as amended; and
5. this Resolution is non-assignable, non-transferrable and site-address specific.


